# **INSTRUCTIONS TO THE TENDERERS**

The Tender shall be submitted in accordance with these instructions, as under:-

# 1. Abbreviations:

Throughout this tender document, the word/ term:

- a) **VTI** means Vaish Technical Institute Rohtak
- b) Working day means Monday to Friday in week
- c) Tender means tender number VTI/01/2024
- d) **Machines** means the machines as detailed at Annexure-A.
- e) **EMD** means Earnest Money Deposit.
- f) **Purchaser** means Vaish Technical Institute Rohtak
- g) Bid means the document and financial details submitted by bidder.
- h) **Bidder** means the eligible and qualified Original Equipment Manufacturers/ Distributors/ Dealers dealing in Computer Systems & Printers
- i) Tenderer means the eligible and qualified Original Equipment Manufacturers/ Distributors/ Dealers dealing in Computer Systems & Printers
- j) **OEM** means Original Equipment Manufacturer

# 2. Eligible Bidder:

# 3. Location of supplies:

a) The details of location where the machines are to be supplied through this tender is as under:

- b) The bidder is free to inspect the location before submitting the bid under this tender.
- c) It may be noted that Principal Vaish Technical Institute Rohtak has full rights to cancel the Tender even after calling the offers from bidders but before the issue of supply order to execute the supply by the bidder. The reason for cancellation will not be disclosed.

# 4. Scope of Supplies:

- a)The machines shall be supplied in compliance to the specifications mentioned in Annexure- A of the tender.
- b)The specifications of the machines as mentioned in the Annexure- A are the requirements of tender.
- c) After the supply of machines as mentioned in the Annexure- A, the bidder has to execute its installation at Vaish Technical Institute Rohtak. No extra cost shall be paid for this reason.
- d) The bidder shall offer on-site warranty of machines as per Annexure - A from the date of supply of machines at Vaish Technical

Institute Rohtak. The purchaser is not liable to pay any extra charges on any account during warranty period.

#### 5. Delivery

- a) The purchaser is interested for complete delivery of machines by the bidder within Fifteen (15) days from the date of issue of supply order. However, the bidders have an option to submit the best delivery time, but in any case the delivery should be before 15 days from the date of issue of supply order by purchaser.
- b) The material shall be inspected on receipt at site and bidder shall be responsible for any damage during the transit of machines.
- c) The bidder shall not arrange part shipments and/or trans-shipments without the permission of purchaser. The insurance cover, if any, including insuring the goods against the loss or damage incidental to manufacture or acquisition, transportation, storage, delivery & installation shall be obtained by the bidder in his own name and not in the name of purchaser. The purchaser will as soon as possible but not later than 30 days from the date of arrival of goods at destination shall notify the bidder of any loss or damage to the goods.

#### 6. Warranty

- a) The bidder shall offer on-site warranty of machines as per Annexure - A from the date of supply of machines at Vaish Technical Institute Rohtak & shall cover each and every part of the machines. The purchaser is not liable to pay any extra charges on any account during warranty period.
- b) Any part or parts proved defective within the on-site warranty period specified above, owing to defect in design, material or workmanship; the bidder shall have to replace them at the place of installation without asking for any charges.
- c) During the warranty period, expert(s) shall be deputed at site by the bidder within three working days from the date of request from purchaser, to rectify and fixing the defects of machines at the location where machines are supplied. The cost of deputation of expert(s) and any other associated expenditure shall be borne by the bidder.

#### 7. After Sales Services

- a) The bidder shall ensure to render after sales services during the warranty period to the satisfaction of purchaser.
- b) The bidder will depute their engineer within three working days to attend the service call received in writing from purchaser.

#### 8. Tender documents:

a) The tender document can be collected from the office of Principal, Vaish Technical Institute Rohtak (Haryana)-124001 in between the period from 12<sup>th</sup> August 2024 to 02<sup>nd</sup> September 2024 (except Saturday & Sunday) between 9:30 hours to 16:00 hours.

Alternatively, tender form can be downloaded from our website **www.vtirohtak.edu.in** from **12<sup>th</sup> August 2024**.

b) At any time prior to the deadline for submission of bids, the Purchaser may amend the Bidding Documents by issuing addendum/Corrigendum. The prospective bidders are advised to remain in touch with the Website for any update in respect of this tender.

### 9. Authorization for submission of tender:

- a) The original and all copies of the bid shall be signed by a person duly authorized to sign on behalf of the Bidder. The written confirmation of authorization (in form of letter on the bidder's letter head) to sign on behalf of the bidder confirming the signature as a person duly authorized to sign should be attached with the technical bid of the tender.
- b) The person signing the tender form or any other documents on behalf of the Bidder shall be deemed to warrant that he has authority to bind the Bidder. If subsequently comes to light that the person so signed had no authority to do so, the purchaser may without prejudice to any other civil & criminal remedies cancel the tender and hold the Bidder liable for all costs, charges and damages.

#### **10. Earnest Money Deposit:**

- a) The EMD shall be submitted in the first envelope super-scribed as "Technical Bid", of prescribed amount by way of Demand Draft drawn in favour of "Principal Vaish Technical Institute Rohtak", Payable at Rohtak. However the EMD may be deposited online in the Institute Account No. 522102010051058 (IFSC Code UBIN0552216, Union Bank of India, VTI Rohtak). The proof of online deposit must be placed in the Technical Bid envelope while submitting the tender. No cash towards EMD shall be accepted. The offers without EMD from the Bidders shall be rejected.
- b) The Purchaser shall not be liable for payment of any interest on EMD.
- c) The EMD will be returned to the unsuccessful bidders soon after the orders are placed on the successful bidder. In case of successful bidder, the EMD will be returned along with payment of machines supplied as per purchase order.

#### **11.** Submission of Tender:

- a) The bidder is to examine all instructions, forms, terms and specifications in the tender documents and to furnish with its bid all documents or information as required by bidding document.
- b) The language for all the correspondence and documents related to the tender shall be in English/ Hindi only.
- c) The tender must be placed in a properly sealed bigger envelope addressed to "Principal Vaish Technical Institute, Behind Railway Station, Rohtak, Haryana-124001". The said bigger envelope shall contain two sealed envelopes containing Technical & Financial bids. The bigger envelope must be super-scribed -Tender for the purchase of Computers and Printers. The two sealed envelopes inside the bigger envelope must be super-scribed as:

Envelope No-1: The said envelope is for Technical bid & shall be super-scribed as "**Tender for the Supply & Installation** of Computer Systems and Printers – Technical Bid"

Envelope No-2: The said envelope is for Financial bid & shall be super-scribed as "**Tender for the Supply & Installation** of Computer Systems and Printers – Financial Bid"

- d) If both or either of the envelopes are not sealed and marked as required, the Purchaser will assume no responsibility for the misplacement or premature opening of the bid.
- e) All the columns of the tender shall be duly, properly and exhaustively filled in. Any cutting/over writing etc. in the tender must be signed by the person who is signing the tender.
- f) Tenders received in open covers/ letters/ fax/ email will not be considered.

# **12.** Financial Bid Submission:

- a) Bidder shall take into account all costs including Packing, Freight, Transportation Cost etc. as detailed at Para 3 of "Instructions to the Tenderer" before quoting the Price of Machines including GST/ Taxes in the Financial Bid.
- b) The Price of Machines shall remain firm & inclusive of all costs for the delivery to the destination which include the cost of Installation at destination.
- c) No extra payment or revision of Price of Machines including GST/ Taxes shall be accepted on account of any discrepancy in nomenclature of items. The Bidder is advised to seek clarification, if any, desired before submitting the tender.
- d) No representation for the revision of the quoted Price of Machines including GST/ Taxes shall be considered till the supplies are completed to the designated location.

#### 13. Last date of submission of Tender:

- a) The tender should reach in the office of "Principal Vaish Technical Institute, Behind Railway Station, Rohtak, Haryana-124001" by 02<sup>nd</sup> September 2024 up to 17:00 hours.
- b) The purchaser may, at its discretion, extend the deadline for the submission of bids by amending the Tender Documents, in which case all rights and obligations of the Purchaser and Bidders previously subject to the deadline shall thereafter be subject to the deadline as extended. The prospective bidders are advised to remain in touch with website for any update in respect of their tender.
- c) The purchaser shall not consider any bid that arrives after the deadline for submission of bids. Any bid received by the Purchaser after the deadline for submission of bids shall be declared late,

rejected and returned unopened to the Bidder.

#### 14. Opening of Technical Bid:

**The technical bid for the tender shall be opened on 03<sup>rd</sup> September 2024 at 15:00 hours in the** O/o Principal Vaish Technical Institute, Behind Railway Station, Rohtak, Haryana-124001. The Bidder or their authorized representative (One person only) may be present at the time of opening of the tender and Technical bid.

#### **15.** Opening of Financial bid:

**The Financial bid of only technically qualified bidders shall be opened on 04<sup>th</sup> September 2024 at 15:00 hours in the** O/o Principal Vaish Technical Institute, Behind Railway Station, Rohtak, Haryana-124001. The Bidder or their authorized representative (One person only) may be present at the time of opening of the Financial bid.

#### **16. Validity of tender:**

The tender shall be valid for a period of 30 days from the date of opening of the Technical Bid of tender. Terms and Financial details submitted in the bid shall be treated as firm during the said period of 30 days.

#### **17. Evaluation of Bids:**

- a) To assist in the examination, evaluation, comparison of the bids and qualification of the Bidders, the Purchaser may, at its discretion, ask any Bidder for a clarification of its Bid. Any clarification submitted by a Bidder in respect to its Bid and that is not in response to a request by the Purchaser shall not be considered. The Purchaser's request for clarification and the response shall be in writing only.
- b) If a Bidder does not provide clarifications of its bid by the date and time set in the Purchaser's request for clarification, its bid may be rejected.
- c) The Purchaser reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to supply order, without thereby incurring any liability to Bidders. In case of annulment, EMD deposits shall be promptly returned to the Bidders.
- d) The Purchaser shall compare the evaluated prices of all substantially responsive bids to determine the lowest evaluated bid.
- e) At the time the Contract is awarded, the Purchaser may increase/ decrease the Quantity of machines without any change in the unit prices or other terms & conditions of the bid and the Bidding Documents subject to the acceptance of bidder in writing for the same.
- f)The purchaser have right to verify the particulars furnished by the bidder independently.

#### 18. Earnest money forfeit:

The EMD will be forfeited in following cases:

- If the bidder fails to accept the order based on his offer (bid) and within the prescribed time.
- If the bidder fails to supply the Machines with specifications as mentioned in Annexure–A
- If the bidder delays supplies beyond a reasonable time.
- If the bidder for any reason whatsoever, withdraws the tender after it is accepted or become unable or fails to execute the orders within stipulated delivery period.
- Submission of misleading/ contradictory/ false statement or information and fabricated/invalid documents detected before or after the issue of order to execute the supplies.

#### **19. Notification of award:**

Prior to the expiry of the period of bid validity, the purchaser shall notify the successful Bidder, in writing, that its Bid has been accepted. The notification letter shall specify the sum that the Purchaser will pay to the bidder in consideration of the supply of Machines at **Vaish Technical Institute Rohtak, Haryana-124001**.

#### 20. Packing:

- a) The bidder shall provide packing of the machines as is required to prevent their damages or deterioration during the transit to their final destination. The packing shall be sufficient to withstand, without limitation, rough handling during transit. In case the consignment received with damaged packaging, the purchaser will not accept the delivery.
- b) The machines shall be securely boxed, crated and protected from mechanical damage, moisture etc. suitable for both storage and transit according to the nature of the material and mode of transport. The bidder shall be responsible for any loss/ damage to material during transportation to the designated location i.e. Vaish Technical Institute Rohtak, Haryana-124001.

#### **21. Delivery Time:**

a) The purchaser is interested for complete delivery of machines by the bidder within Fifteen (15) days from the date of issue of supply order. However, the bidders have an option to submit the best delivery time, but in any case the delivery should be before 15 days from the date of issue of supply order by purchaser. In case bidder fails to supply within the period of delivery indicated above, penalty @ 1% of value of the order per week of delay would be levied subject to maximum 4 weeks. It means, the bidder shall have the liability of delayed supply to the maximum of 4 weeks after expiry of scheduled delivery date. After that the supply order shall be cancelled and EMD will be forfeited and bidder will be debarred from participation in any future tenders.

#### 22. Payment:

The payment of total bill along with EMD will be made by the purchaser by crossed account payee Cheque/RTGS/NEFT for which the bidder shall send bills at the time of Supply & Installation.

#### **23.** Causes of rejection of tender:

- a) While submitting the tender, if any of the prescribed conditions are not fulfilled or are incomplete in any form, the tender is liable to be rejected.
- b) If any Bidder stipulates any condition of his own, such conditional tender is liable to be rejected.

#### 24. Claims:

- a) If the material supplied are found to be off size and shape different than those in the accepted offer and are of specifications lower than those stipulated in the accepted offer, the purchaser shall have right to totally reject the machines.
- b) The bidder shall be responsible for arranging the rejected machines to be removed at his cost from purchaser premises.

#### 25. Address for communication:

All the communication with respect to the tender shall be addressed to: Principal, Vaish Technical Institute, Behind Railway Station, Rohtak, Haryana-124001

#### **26. Code of Ethics:**

The Purchaser as well as the Bidder shall observe the highest standard of ethics including laws against fraud and corruption in force in India, during the procurement or execution of such contracts. If the bidders are found in Bid pooling or against law, then their firms may be blacklisted.

#### **27. Jurisdiction:**

In the event of any dispute the legal matter shall be subjected to the jurisdiction of Court in Haryana State only.
